

Pursuant to Article 13 of the General Data Protection Regulation (hereinafter GDPR) of 27 April 2016 (Official Journal of EU L 119 of 04.05.2016) I acknowledge that:

- The controller of your personal data is: Pomorski Park Naukowo Technologiczny Gdynia Jednostka Budżetowa Gminy Miasta Gdyni, Al. Zwycięstwa 96/98, 81-451 Gdynia, NIP [Tax ID No.] 5862312326 (hereinafter: Controller).
- 2. In matters related to your data, please contact the Data Protection Officer appointed at the Controller: biuro@ppnt.pl, phone 58 880 81 50.
- 3. Your personal data shall be processed on the basis of applicable legal provisions: to exercise the statutory activity of the Controller (including recruitment, promotion and information activities); for accounting and book-keeping purposes, as well as to determine, pursue and defend against claims, which is the legitimate interest of the Controller and to prepare and implement the rental agreement (legal basis: Article 6(1)(a),(b),(c) GDPR).
- 4. Your personal data shall be used and stored by the time of the end of achievement of the purposes indicated above (point 3) i.e. for the time necessary to implement the agreement or by the time of withdrawal of the consent, and after that time for the period and in the scope consistent with applicable laws and regulations i.e. for the purpose of fulfilling the obligations stipulated in legal provisions, for archival purposes, to assert claims or defend own rights, maximum for the period of 10 years, or by the time of lodging a justified objection by you to the processing of personal data.
- 5. The recipients of your personal data shall be authorized public authorities, entities/institutions specified by legal provisions or entities cooperating with the Controller on the basis of concluded contracts and agreements (including entities which process entrusted data) during performance of the activities related to the statutory activity of the Controller.
- 6. Your personal data shall not be processed in automated way and shall not be subject to profiling, as well as shall not be provided outside the European Economic Area.
- 7. Under the rules specified in regulations on personal data protection you have the right to demand access to your personal data, demand rectification thereof, demand erasure thereof or limit the processing thereof and right to data portability. At all times you have the right to object to the processing of data under the rules and in the scope arising from GDPR. If the processing of personal data takes place on the basis of the consent, you have the right to withdraw that consent at all times. Such withdrawal shall not affect conformity of the processing to the applicable law, made on the basis of the consent prior to its withdrawal. The right to lodge an objection to the data processing shall not be vested if: processing of personal data takes place on the basis of the controller to fulfil the legal obligation. The aforementioned demands may be sent to the addresses indicated in points 1) and 2).
- 8. You have the right to lodge a complaint to the supervisory authority i.e. the President of the Personal Data Protection Office with its registered office at the address: ul. Stawki 2, 00-193 Warsaw.
- 9. The provision of the personal data by you is voluntary, however failure to provide the data may result in impossibility of participating in the recruitment process (including impossibility of concluding the rental agreement) at the Controller.
